BACKGROUND

Poly-D-Lysine (PDL) is a positively-charged, synthetic molecule used as a thin coating to enhance the attachment of cells to plastic and glass surfaces. It has been used to culture a wide variety of cell types, including human amniotic fluid cells and chick embryo cells.

PRODUCT

Poly-D-Lysine HBr, high molecular weight is supplied as 20 mg, lyophilized from a membrane-filtered (0.2 μ m) aqueous solution (purity: > 98%).

Poly-D-Lysine is generally used in the concentration range of 2.5-5.0 μ g/cm² of growth surface. Coating protocols are provided as guidelines only; each laboratory should empirically determine the optimal conditions for their unique applications.

The contents of this vial have been tested and found negative for the presence of bacteria, fungi and mycoplasma.

Molecular Weight of Poly-D-Lysine HBr, high molecular weight: 500-550 kDa.

RECONSTITUTION

To reconstitute Poly-D-Lysine, equilibrate vial to room temperature. Resuspend in sterile distilled water and swirl to dissolve. If entire amount of material is not to be used immediately, transfer aliquots to sterile plastic tubes and store at -20° C. Solubilized product should be used within 3 months.

****DO NOT STORE IN FROST-FREE FREEZER. AVOID MULTIPLE FREEZE-THAW CYCLES**.**

RECOMMENDED COATING PROTOCOL

- Dilute Poly-D-Lysine to desired concentration using serum-free culture medium. The final solution should be sufficiently dilute so that the volume added to the coating surface will coat it evenly (e.g. for a final coating concentration of 5 μ g/cm², dilute material to 50 μ g/ml and add 1 ml/35 mm dish, 3 ml/60 mm dish, etc.).
- Add appropriate amount of diluted Poly-D-Lysine to culture surface.
- Incubate at room temperature for 1 hour.
- Aspirate remaining material.
- Rinse plates carefully; avoid scraping bottom surface. Unbound Poly-D-Lysine may be inhibitory to cell growth.

Plates may be used immediately or may be stored at 4° C, damp or air dried, if sterility is maintained.

STORAGE

Stable as supplied for a minimum of 3 months from day of shipment when stored at 2-8° C.
