### 4. FIRST AID MEASURES

### **Description of first aid measures**

#### General advice

### 7. HANDLING AND STORAGE

#### Precautions for safe handling

Use in a chemical fume hood, with air supplied by an independent system. Avoid inhalation, contact with eyes, skin and clothing. Avoid the formation of dust and aerosols. Use in a well-ventilated area. Keep away from sources of ignition. Avoid prolonged or repeated exposure.

### Conditions for safe storage, including any incompatibilities.

Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Store at +4 °C.

### Specific end uses

Use in a laboratory fume hood where possible. Refer to employer's COSHH risk assessment.
