Animal studies suggest that soluble tungsten compounds have the potential for causing adverse health effects involving the gastrointestinal tract and central nervous system. These effects have not been observed in humans. Chronic exposure to tungsten compounds may result in permanent lung damage.

Absorption of silver compounds by ingestion, inhalation or through broken skin can cause argyria, a permanent bluish-grey discoloration of the skin, conjuctiva and mucous membranes.

To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.
