# HIF PHD2 shRNA (m) Lentiviral Particles: sc-45538-V



The Power to Question

#### **BACKGROUND**

Prolyl hydroxylase domain proteins HIF PHD1, HIF PHD2 and HIF PHD3 (also designated EGLN2, EGLN1 and EGLN3, respectively) can hydroxylate HIF-lphasubunits. Hypoxia-inducible factor (HIF) is a transcriptional regulator important in several aspects of oxygen homeostasis. The prolyl hydroxylases catalyze the posttranslational formation of 4-hydroxyproline in HIF- $\alpha$  proteins. HIF PHD1, which is widely expressed, with highest levels of expression in testis, functions as a cellular oxygen sensor and is important in cell growth regulation. HIF PHD1 can localize to the nucleus or the cytoplasm and is also detected in hormone responsive tissues, such as normal and cancerous mammary, ovarian and prostate epithelium. HIF PHD1 is encoded by EGLN2, which maps to chromosome 19q13.3. HIF PHD2 is regarded as the main cel-Iular oxygen sensor, as RNA interference against HIF PHD2, but not HIF PHD1 or HIF PHD3, is enough to stabilize HIF-1lpha in normoxia. HIF PHD2, a direct HIF target gene, is expressed mainly in skeletal muscle, heart, kidney and brain. HIF PHD3 may play a role in the regulation of cell growth in muscle cells and in apoptosis in neuronal tissue. HIF PHD3 is widely expressed, although the highest levels can be detected in placenta and heart.

#### **CHROMOSOMAL LOCATION**

Genetic locus: Egln1 (mouse) mapping to 8 E2.

#### **PRODUCT**

HIF PHD2 shRNA (m) Lentiviral Particles is a pool of concentrated, transduction-ready viral particles containing 3 target-specific constructs that encode 19-25 nt (plus hairpin) shRNA designed to knock down gene expression. Each vial contains 200  $\mu$ l frozen stock containing 1.0 x  $10^6$  infectious units of virus (IFU) in Dulbecco's Modified Eagle's Medium with 25 mM HEPES pH 7.3. Suitable for 10-20 transductions. Also see HIF PHD2 siRNA (m): sc-45538 and HIF PHD2 shRNA Plasmid (m): sc-45538-SH as alternate gene silencing products.

#### **STORAGE**

Store lentiviral particles at  $-80^{\circ}$  C. Stable for at least one year from the date of shipment. Once thawed, particles can be stored at  $4^{\circ}$  C for up to one week. Avoid repeated freeze thaw cycles.

#### **APPLICATIONS**

HIF PHD2 shRNA (m) Lentiviral Particles is recommended for the inhibition of HIF PHD2 expression in mouse cells.

#### **SUPPORT REAGENTS**

Control shRNA Lentiviral Particles: sc-108080. Available as 200  $\mu$ l frozen viral stock containing 1.0 x 10 $^6$  infectious units of virus (IFU); contains an shRNA construct encoding a scrambled sequence that will not lead to the specific degradation of any known cellular mRNA.

#### **GENE EXPRESSION MONITORING**

HIF PHD2 (G-17): sc-34920 is recommended as a control antibody for monitoring of HIF PHD2 gene expression knockdown by Western Blotting (starting dilution 1:200, dilution range 1:100-1:1000) or immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500).

To ensure optimal results, the following support (secondary) reagents are recommended: 1) Western Blotting: use donkey anti-goat IgG-HRP: sc-2020 (dilution range: 1:2000-1:100,000) or Cruz Marker™ compatible donkey anti-goat IgG-HRP: sc-2033 (dilution range: 1:2000-1:5000), Cruz Marker™ Molecular Weight Standards: sc-2035, TBS Blotto A Blocking Reagent: sc-2333 and Western Blotting Luminol Reagent: sc-2048. 2) Immunofluorescence: use donkey anti-goat IgG-FITC: sc-2024 (dilution range: 1:100-1:400) or donkey anti-goat IgG-TR: sc-2783 (dilution range: 1:100-1:400) with UltraCruz™ Mounting Medium: sc-24941.

#### **RT-PCR REAGENTS**

Semi-quantitative RT-PCR may be performed to monitor HIF PHD2 gene expression knockdown using RT-PCR Primer: HIF PHD2 (m)-PR: sc-45538-PR (20  $\mu$ l, 416 bp). Annealing temperature for the primers should be 55-60° C and the extension temperature should be 68-72° C.

#### **BIOSAFETY**

Lentiviral particles can be employed in standard Biosafety Level 2 tissue culture facilities (and should be treated with the same level of caution as with any other potentially infectious reagent). Lentiviral particles are replication-incompetent and are designed to self-inactivate after transduction and integration of shRNA constructs into genomic DNA of target cells.
