4. First Aid Measures

Ingestion: If any component of this kit is swallowed, wash out mouth with water provided person is conscious. Call a physician or poison control.

Skin Contact: If any component of this kit contacts the skin, flush with copious amounts of water and wash with soap and water for at least 15 minutes. Remove contaminated clothing and shoes. Call a physician if irritation or discomfort develops.
