**Biological Product:** Non-replicative Maloney murine leukemia viral (MLV) particles. Replication-deficient.

### Section 4: First Aid Measures

**Swallowed:** Rinse mouth with water then drink copious amounts of water.  
**Eye Contact:** Wash continuously with water for 15 minutes  
**Skin Contact:** Immediately wash skin with soap and water. Wash contaminated clothing.  
**Inhaled:** Remove to fresh air.  
**Ingested:** Rinse mouth thoroughly with water.  
**Physician's Note:** Treat symptomatically. No specific antidote. Medical staff must contact Poison Control Center. To the best of our knowledge, the chemical, physical and toxicological properties have not been thoroughly investigated
